Introduction

On 1 - 2 July 2024, UNEP-WCMC are convening the Nature Action Dialogues in Cambridge UK. This two-day event will bring together leaders from the private sector and conservation community in the lead up to the United Nations Biodiversity Conference (COP16). The theme of the event is **The Road to CBD COP16: Scaling private sector action in support of global goals**.

UNEP-WCMC is a global centre of excellence on biodiversity and nature's contribution to society and the economy. We support and empower leaders across all sectors of the economy to take action on nature. The UNEP-WCMC Proteus Partnership has worked with multinational businesses for over 20 years, supporting them to contribute to a clean, healthy, and resilient environment for all.

The Dialogues will feature speakers and organisations from across the business and nature landscape. Structured around interactive workshops and discussions, attendees will have opportunities to share collective knowledge and experience on a range of key topics. A broad attendee base is anticipated to the event, including businesses representing different sectors, financial institutions and various conservation organisations.

Meeting objectives and benefits

- Accelerating ambition towards delivery of the Kunming-Montreal Global Biodiversity Framework ahead of COP16 and exploring the role of business in contributing towards global biodiversity and nature goals.
- Convening a broad cross-sector and conservation group to share knowledge and expertise on key topics to inspire action and innovative solutions.
- Building engagement on biodiversity with a cross-sector group of businesses and strengthening the role of UNEP-WCMC and other conservation organisations in enabling them to assess, commit, transform, and disclose their relationship with nature.
- Collaboration with industry experts and conservation leaders to develop actionable strategies for advancing biodiversity conservation and supporting global goals.
- Connecting with like-minded professionals through a series of dynamic and interactive workshops that explore opportunities for collective impact.
